- client is a PhD student in mathematics at Queens.

 Teaches both at Queens and RMC on a contract
 basis.
- Common law spouse, Allegra Coleman, and two children age 4 and 2.
- loaned his house to a friend when client went on vacation for a week: left on August 12/15. Returned on Aug 19/15. Friend said he would look after house. Thought doing friend a favour.
- friend: G.W. Peck ("peckster" is how client kept referring to him, weird). Also PhD student in math. Works as a financial analyst in own business. Not

- sure of name. Thinks the husiness is Internet-hased and Peck does analysis for banks.
- HUGE amount of damage to the house garbage everywhere, broken walls, broken plumbing fixtures etc, see pictures. In process of being HAZMAT cleaned.
- Neighbours say that there were huge parties at night. Police called. Tried to reach client but didn't know his cell number or Allegra's number. Very frustrated and angry neighbours. Client afraid that they will sue him for any damage to their yards, etc.
- Client says that there were Fachook posts from Peck and his friends advertising an open party, now taken down. Peck blocked him on FB.
- Client says that Peck is a hit of nevd and may have just been taken advantage of by someone else, but really doesn't know him that well
- Insurance claim filed but agent said unlikely that insurance company will pay as client did not have coverage for house being left in custody of someone else. Deliberate damage outside policy as well. Client will probably have to pay personally.
- Client has had initial estimate to repair damage at least \$150,000
- Client will get and provide written estimates from at least two potential repair companies

- Peck avoiding client; has not returned emails, texts, or calls.
- Peck lived in student housing at university

 (Harkness Hall) this summer and last year but no
 one that client knows has seen him in the last month.
- Client says he knows that Peck is still registered for his program and pretty sure still working as a TA at Queens. Unlikely that he would not keep up with his research or neglect his teaching—ambitious.
- Not sure where Peck lives when not in school; client thinks he's from Toronto. Client pretty sure Peck had planned to be in Harkness Hall again for this academic year.
